- x. To grant receipts for aid or donation received.
- xi. To grant Special Power of Attorney to represent the Trustees in connection with any legal or other proceedings.
- xii. To acquire land or building on the lease or way of purchase.
- xiii. To compromise, compound or refer to Arbitration all actions, proceedings and disputes relating to Trust property or properties.
- xiv. To sell or give on rent/lease or on hire any immovable or moveable property of the Trust for some certain period (s) on such terms and conditions as the Trustees may think fit and proper from time to time.
- xv. To open any type of bank account (s) whether saving account, current account, fixed or otherwise, in the name of the Trust or institution (s) or programme (s) run by the Trust with any scheduled banks (s) or post office (s) and to operate by the authorized signatory or signatories as Board of Trustees shall think fit and proper to authorize any person or persons, unless and until determined otherwise the such bank account(s) shall be opened and operated jointly with signatures of any two members of Board of Trustees. xvii. To gift, lease, and transfer the immovable and moveable properties of the Trust.

xviii. To appoint lawyer, pleaders, advocated to file and defend suit or suits filed for and against the Trust and or in the name of the Trust and also file suits for financial and other disputes or dues with different parties and signed executed such application, petition documents for such proceedings and delegate powers to the officers(s), employee(s), staff(s) and Trustee(s) for such proceedings(s) as required from time to time.

xix. To appoint new member or members of Board of Trustees by a resolution and to discharge any of the Trustee, who become bankrupt or acts in any manner prejudicial to the interest or objects of the Trust or is convicted of an offence involving moral turpitude or becomes of unsound mind or is otherwise unfit to continue as Trustee, by resolution passed by simple majority of members present and voting in the meeting of Board of Trustees.

xxi. After defraying all necessary expenses incurred in the collection or realization of the income from the Trust ten percent (10%) of the balance of the income shall be kept in a reserve fund to be utilized when, in the opinion of the Board of Trustees, there is any emergency and the remaining income may be utilized for the purpose of the Trust.

xxii. The Trustees shall invest the Trust fund in government securities, saving certificates, fixed deposits or in any other form of investment authorized under provisions of INDIAN TRUST ACT and INDIAN INCOME TAX ACT, 1961, as they shall deem expedient.

xxiii. It has further been decided that as and when the Trust is enclosed or dissolved all the funds of the Trust shall be transferred to the other recognized Public Charitable Trust having similar objectives.

xxiv. All questions relating to the management of the Trust or the exercise of the powers vested in the Trust shall be decided at a meeting or, if necessary and expedient, by circulation. Every such question shall be decided by a majority of the Trustees present and voting in any meeting of Board of Trustees or by the circulation, as the case may be and any action or decision of such majority shall be as valid as if it was done or made by the all Trustees.

xxv. In case of occurrence of any vacancy amongst the Trustees because of death, resignation or incapacity of any Trustee or any other cause, a new Trustee may be appointed to fill the Vacancy in line with memorandum of the trust.

xxvi. All matters not provided for in this Trust deed but necessary for the administration of the Trust or for giving effect to the objectives of the Trust may by resolution(s) made by the Board of Trustees.

xxvii. The powers and duties of Principal trustee and the Member Trustee shall be determined by the Board from time to time. The Power to appoint Trustees and Principal Trustee from time to time shall vest with the Board.

xxviii. The Board of Trustees shall have the power to appoint one or more persons as Trustees. The Trustees shall hold office for such period as the Board may determine or till they cease to be trustees in terms or clause (xxix) below or till they are removed by the Board.

xxix. No persons shall be eligible to be appointed as a Trustee and a Trustee shall cease to hold office if: -

7. He/she is, or become a person of unsound mind.
8. He/she has been, is convicted of an offence involving moral turpitude,
9. He/she has been or is adjudged insolvent,
10. He/she is, or become deaf mute, or is suffering from a bodily infirmity which shall render him unfit for active work,
11. He/she is otherwise disqualified to act as a Trustee according to the provisions in the Indian Trusts Act 1882
12. He commits any breach of Trust.

**14. PROCEEDING OF THE BOARD:**

a) The Board shall meet as often as necessary to transact the business relating to the Trust provided that they shall meet at least once in every three calendar month.

b) Principal Trustee shall preside over Board meeting as Chairman and in his absence any one of the Trustees shall be elected to preside over the meeting.

- c) Half plus one member of the total strength of the Board shall form the quorum for the Board meeting.
- d) A minute book with pages serially numbered shall be maintained for recording the resolutions passed at the Board Meetings. The Minute Book shall be written up to date within 10 days from the date of meeting or the date of the next Meeting whichever is earlier. The Minute of each meeting shall be duly authenticated by the Chairman of that Meeting.
- e) Every Trustee present at any Meeting shall sign his name in the book kept for that purpose.
- f) In all matter pertaining to the Trust the decision of the majority of the Trustees shall be final in case of equality of votes the Chairman there at shall have an additional (casting) vote.
- g) The Board shall have the power to delegate any of its powers to any of the Trustees to the extent it considers necessary or expedient.

**15. ASSETS & FUND:**

The Trustees shall maintain Bank Accounts in the name of the Trust and the same shall be operated by the Trustees or by any such persons as the Board may resolve from time to time.

**16. DONATIONS AND CONTRIBUTIONS:**

- a) The sum of Rs.30,001/- (Rupees Thirty Thousand and One only) initially contributed by the AUTHOR of the Trust towards the corpus of the Trust is hereby acknowledged by the Trustees as having received.
- b) The Board shall have the power to accept from India or abroad contribution (including Donation, sponsorship, Fees, Grants and Aid) in money, in kind, in landed & property or in any other mode either by way of addition to the general corpus of the Trust or for being applied on any one or more of the specified objects of the Trust or for general purpose of the Trust.

**17. INVESTMENTS:**

a) Such of the money of the Trust that cannot be applied immediately or at an early date for the purposes of the objects shall be kept invested in such manner and in such mode as the Board may decide subject to the regulations contained in the Indian Trust Act, 1882 and the Income Tax Act, 1961.

b) The board shall have the power to realize or otherwise dispose of any or all of the investment from time to time in the interest of the Trust. The Board may utilize the proceeds of such realization or disposal for any of the objects of the Trust and or for reinvestment as provided in sub-clause (a) above.

c) All investment shall be made in the name of the Trust. The Trustee/Trustees authorized by the Board shall execute the necessary documents on behalf of the Trust for the purposes of sub-clauses (a) and (b) above.

**18. BORROWING POWERS:**

The Board shall have the power to raise loans for the purposes of the Trust and to repay the same from out of the income or funds of the Trust. The Board shall give such security or guarantee as may be required and resolved by the Board and shall also accept the security or guarantee that may be provided by the Trustees or any other such persons as may be required and resolved by the Board.

**19. ACCOUNTS AND AUDIT:**

Proper books of accounts shall be maintained by the Trust regularly. The books of accounts shall be closed on 31<sup>st</sup> March every year. A duly qualified Auditor appointed by the Board shall audit the accounts.

**20. LIABILITY OF TRUSTEES:**

a) A Trustee resigning his office or otherwise ceasing to be a Trustee shall not, by reason of the fact alone be relieved from his liability to the Trust or to his co-Trustee in respect of his acts of commission or omission or defaults during the period of Trusteeship. No Trustee shall be made liable for the acts or defaults of his predecessors, but where co- Trustees jointly commit a breach of Trust, each shall be jointly and severally liable for the whole of the loss or consequences occasioned by the breach.

b) The Trustees shall not be liable for any loss that may be caused to the Trust funds, property or assets, unless the Trustees are found guilty of fraud or criminal breach of Trust by a competent court of law. The private liabilities of the Trustees collectively or individually shall not affect the Trust.

**21. RULES AND REGULATIONS:**

a) The Board is hereby authorized to make rules, regulations and by-laws for the purpose of the management and administration of the Trust and of the activities of the Trust.

b) The Board of Trustees may by any supplementary instruments, additional rules and bye-laws confer and provide for such powers as may be required for the purpose of the management and proper administration of the Trust.

**22. CYPRES / DISSOLUTION:**

If at any time and for any reason, the objects of the Trust should become impossible of fulfillment or performance, the funds of the Trust shall be given to any other Public Charitable Trust or Trusts or Institution having similar objects, as the Board may determine.

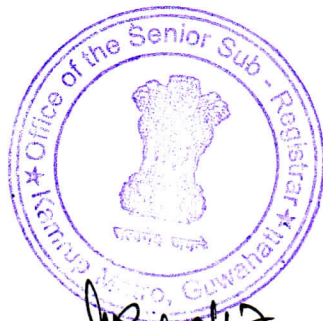
